# Chad Vale Primary's Publication Scheme on information available under the Freedom of Information Act 2000

The governing body is responsible for maintenance of this scheme.

#### 1. Introduction: what a publication scheme is and why it has been developed.

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- The classes of information which we publish or intend to publish;
- The manner in which the information will be published; and
- Whether the information is available free of charge or on payment.

The scheme covers information already published and information, which is to be published in the future. Some information in our publication scheme is available on our website (School Prospectus), or available in paper form. We aim to have all publications with the exception of Governors' Documents available on our website. All documents are available in paper form.

Some information, which we hold, may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

## 2. Aims and Objectives

The school aims to:

- Be a magnet for learning where the school team, parents and children recognise their broad and diverse range of challenging achievements (inclusive of literacy, numeracy and ICT) gained with increasing independence and a secure sense of community and appropriate self esteem.
- Meet the needs of all our pupils by involving them in an appropriate, broad and balanced curriculum.
- Set standards of excellence in the teaching and learning experiences we offer and to give our pupils the opportunity to acquire knowledge, understanding, skills and attitudes which will be the key to their success in future education and adult life.
- Foster partnerships with parents and the wider community which support children's development and help them to understand their future role in society.
- Achieve efficient management of school finances and to provide a pleasant, safe and stimulating learning environment for our pupils.

- Develop and sustain a happy and secure environment in which our children gain in confidence and independence, while learning to accept responsibility and to make a positive contribution to a caring school environment.
- Continually enhance and improve basic skills for all our children through a partnership between all staff, children and their parents or guardians.

This publication scheme is a means of showing how we are pursuing these aims.

## 3. Categories of information published.

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

- **School Prospectus and School Profile** information published in the school prospectus and statutory information required in the School Profile.
- **Governors' Documents** information published in the Governors Annual Report and in other governing body documents.
- **Pupils & Curriculum** information about policies that relate to pupils and the school curriculum.
- School Policies and other information related to the school information about policies that relate to the school in general.
